Shaky first quarter

VFF Pension showed positive trends in 2017 and the total return was 5.2 %. The key indicators remained encouraging, with a solvency ratio of 129 % and a consolidation level of 115 % at end December.

However, 2018 got off to a much shakier start, and the share portfolio which was the biggest contributor last year is now showing negative after the first quarter. As a result we have reduced the bonus rate to 5 % for Volvo Företagspension and 7 % for PLUSpension. We are continuing our drive to maintain a robust and diversified portfolio that can deliver healthy returns. At the end of the year the share portfolio was supplemented with a couple of global small-company funds.

In May new data protection legislation comes into force and preparations are in full swing. This spring will also see a referral round for the new regulations governing Occupational Pensions, which are expected to come into force next year.
